Save even more when you use the mail service pharmacy

You can get your prescription medications shipped to your home from CVS Caremark® through our network's mail service delivery program. For even more convenience, you can sign up for the automatic refill program, so you don't need to re-order every time your prescription runs out. Typically, you can expect your prescriptions to arrive within 10 calendar days of the mail service pharmacy receiving your order.

90-day mail service Tier 1 copays are the same as 30-day preferred retail copays for both Blue MedicareRx Value Plus (\$1) and Blue MedicareRx Premier (\$1) members.

KEEPING YOU IN THE KNOW

We always want to keep you well informed about any changes that could affect your Medicare plan, including updates mandated by the Inflation Reduction Act (IRA).

These changes will take effect on January 1, 2025:

Elimination of the Medicare coverage gap and introduction of a \$2,000 annual cap on prescription costs. Depending on your medications, the savings could really add up.

An option to stretch out your payments. If you have high drug costs and are likely to reach the \$2,000 annual cap early in the year, you'll be able to pay your out-of-pocket prescription costs in monthly installments.

SAVE WITH **RxSAVINGS PLUS**

Now you can get discounts on select prescription medications not covered by your Part D plan with the RxSavings Plus program for Medicare.* Simply present your prescription, your current member ID card, and CVS Caremark plan ID card at the pharmacy counter at participating CVS network pharmacies and you may be offered a discount on select non-covered medications.

There is no cost to take part in this program, and no additional card or enrollment is needed. Examples of non-covered drugs include antihistamines, cough, cold, and allergy medications, dermatologicals, laxatives, multivitamins, and minerals.

GET WEEKLY SAVINGS AT CVS

Use your CVS Pharmacy[®] ExtraCare[®] card every time you shop, and save 20% on eligible products. If you've misplaced your ExtraCare card and need another one, call Customer Care.**

Annual formulary changes

Each January, the list of covered drugs (formulary) may change. We encourage you to closely review our Annual Notice of Change (ANOC) document you received last month. Medicare's Extra Help program

People with limited incomes may qualify for Extra Help to pay for their prescription drug costs. If you qualify, Medicare could pay up to 75% or more of your drug costs including monthly prescription drug premiums, annual deductibles, and co-insurance. Additionally, those who qualify won't have a late enrollment penalty. Many people are eligible and don't even know it.

TIPS FOR MANAGING YOUR MEDICATIONS

How to take your medication safely

Use these tips to better understand the medications you're taking, how to use them, and the risks you may face.



If your doctor prescribes a medication for you, find out as much as you can about the medication, including how to take it properly.



Make sure to show your member ID card every time you're at the pharmacy. This allows your pharmacists to perform safety checks against unsafe drug interactions. Use the same pharmacy to aid in these checks.



Some medications should be used with caution by patients over the age of 65. Talk to your doctor about side effects and safer alternatives.

How to report suspicious or fraudulent prescription drug activity

Detecting and preventing prescription drug fraud, waste, and abuse is a group effort. Blue MedicareRx encourages members to report any suspected fraudulent activities. All reports are treated as confidential and will be investigated. To make a report, or if you have questions or are unsure whether a situation really involves fraud, waste, or abuse, please contact us.
